<p>1. Context and aim of event selection</p>	<p>1.1. Archery GB are responsible for administering the selection process for the Olympic Games on behalf of the British Olympic Association (BOA). The process herewith enables the nomination of athletes to the BOA who ratify final selection against their Qualification and Selection Strategy, the primary focus of which is to endorse athletes who will deliver credible performances at the Olympic Games.</p> <p>1.2. The 2024 Paris Olympics is Archery GB’s key milestone event for the Paris cycle and builds upon the open selection process held in 2022 for the European Championships and 2023 for the European Games and World Championships. The aim of this selection policy is to select a team that maximises medal opportunities in individual and team events at the Olympic Games.</p> <p>1.3. In selecting a team, consideration will be given to the following objectives.</p> <p>1.3.1. Selecting athletes with the potential to win an Olympic medal in Paris either individually or part of a team.</p> <p>1.3.2. Selecting athletes with demonstrable future potential to win an Olympic medal in LA 2028 and beyond</p> <p>1.4. The European Championships, World Cups, Spring Arrows World Ranking event and any other World Ranking event in 2024 identified by Archery GB will be used as preparation events for the Olympic Games. Consequently, the team selected will attend all identified events from the first the Spring Arrows Event in April 2024 onwards.</p> <p>1.5. Therefore, in nominating a team to the British Olympic Association the selection criteria in section 4 will be applied in order to align with the BOA’s Qualification & Selection strategy.</p>

<p>3. General Points of Eligibility</p>	<p>3.1. Athletes are eligible for consideration provided:</p> <p>3.2. They are an Archery GB member in good standing</p> <p>3.3. Have satisfied all eligibility under the rules of World Archery (WA) and subject to any changes it may introduce after the publication of this policy</p> <p>3.4. Are eligible to compete for Great Britain</p>

	<p>3.5. They hold a valid British passport that cannot be more than 10 years old from the date of issue regardless of expiry date and is valid for 6 months after the event</p> <p>3.6. Are available for selection of the stated events</p> <p>3.7. Are fit and healthy to compete</p> <p>3.8. Have met the required EMQS identified in section 11, or have met the required criteria to be considered for a wildcard as identified in section 12 of this policy</p> <p>3.9. Have attained the Minimum Qualification Standards to attend the Olympic Games in the required window – see Appendix 4</p> <p>3.10. Fulfil any other eligibility rule or requirement from the IOC, BOA, WADA, WA or any other relevant international or national governing body or organisation;</p> <p>3.11. Sign a Team Member Agreement (TMA) when required by the BOA.</p>																												
<p>4. Selection Process</p>	<p>4.1. The Selection process will be made up of the following stages</p> <p>4.1.1. Qualification: Athletes wishing to be considered for selection are required to achieve the following:</p> <p>4.1.1.1. Top 12 individual position based upon the ranking of athletes top/ best 3 results at National Tour stages in 2023.</p> <p>4.1.1.2. Achieve Eligibility Score</p> <p>4.1.2. Selection Shoot Process: demonstrate performance level within a series of formats that replicate the demands of international competition.</p> <p>4.1.3. Enhanced Minimum Qualification Standards (see section 11)</p>

	<p>5.2. Following the conclusion of the National Tour, athletes will be ranked using their top / best 3 results at National Tour stages in 2023</p> <p>5.3. The ranking position and finishing position at each stage will be combined and athletes will be ranked based upon their 3 lowest cumulative totals (see Appendix 2 for a worked example) to give a final qualification position</p> <p>5.4. Based upon the final qualification position after the completion of all 6 stages of the national tour a minimum of 8*, up to a maximum of 12 athletes will be invited to the first selection shoot in 2024.</p> <p>5.4.1. *this figure may be lower if insufficient athletes have achieved the eligibility score within the selection window)</p> <p>Eligibility Score:</p> <p>5.5. <p>6. Selection Window</p>	<p>6.1. The window for obtaining the eligibility scores is 1st April 2023 to 31st October 2023.</p>						
<p>7. Registration</p>	<p>7.1. Athletes who have achieved the eligibility scores and attended at least 3 legs of the National Tour and who wish to be considered for the selection shoot are required to complete the following expression of interest and eligibility form and submit by 12:00 noon on 31st October 2023.</p> <p>7.2. Expression of interest form can be found here</p> <p>7.3. Submission should include the link to the official competition results to evidence eligibility score.</p>						
<p>8. Selection Shoot Process</p>	<p>8.1. The intent of the Selection Shoots is to give athletes the opportunity to demonstrate performance level within a series of formats that replicate the demands of international competition.</p> <p>8.2. The points awarded throughout the process will be used by the Selection Panel, alongside the other factors identified in sections 1, 3 and 13, when considering final selections and nominations.</p> <p>8.3. Selection Shoot 1:</p> <p>8.3.1. Date: 1st – 3rd March 2024</p> <p>8.3.2. Location: Performance Archery Centre, Lilleshall National Sports Centre</p> <p>8.3.3. Format – See Appendix 3</p> <p>8.3.4. The top 6 athletes at the end of Stage 1 will be invited to Stage 2.</p> <p>8.4. Selection Shoot 2:</p> <p>8.4.1. Date: 15th – 17th March 2024</p> <p>8.4.2. Location: Performance Archery Centre, Lilleshall National Sports Centre</p> <p>8.4.3. Format – See Appendix 3</p>						

	<p>8.4.4. The top 4 athletes at the end of Stage 2 will be invited to Stage 3 and will also be the nominated team for the World Cup 1 in Shanghai.</p> <p>8.5. Selection Shoot 3:</p> <p>8.5.1. Date: 29th – 31st March 2024</p> <p>8.5.2. Location: Performance Archery Centre, Lilleshall National Sports Centre</p> <p>8.5.3. Format – See Appendix 3</p> <p>8.6. The format for each Selection Shoot may be subject to change based on weather and operational considerations.</p> <p>8.7. Ties</p> <p>8.7.1. <p>9. Bonus Points</p>	<p>9.1. An athlete winning an international medal (individual or team) at one of the following events in 2023 will be awarded 50 bonus points per medal at the start of selection shoot stage 1:</p> <p>9.1.1. World Cup 1 (Antalya)</p> <p>9.1.2. World Cup 2 (Shanghai)</p> <p>9.1.3. World Cup 3 (Medellin)</p> <p>9.1.4. World Cup 4 (Paris)</p> <p>9.1.5. World Cup Final (Mexico)</p> <p>9.1.6. <p>10. Enhanced Minimum Qualification Standard (EMQS)</p>	<p>10.1. Entry into the Olympic Games requires athletes to have attained a minimum qualification standard (MQS). The BOA look to ensure that enhanced minimum qualification standards (EMQS) are in place for sports to ensure athletes at a credible competitive level represent Team GB. By the end of stage 2 of the selection shoots athletes must have attained this EMQS once at a WRS Competition during the following window:</p> <p>10.2.1. 31st July 2023 – End of selection shoot Stage 3 (TBC April/May 2024)</p>	Recurve Men	655	Recurve Women	635

<p>11. Wildcards</p>	<p>Medical Wildcard:</p> <p>11.1. Awarded in exceptional circumstances, for long-term injury / illness / new medical conditions, based on the following criteria;</p> <p>11.1.1. Fully unavailable to shoot for 4-6 weeks due to injury / illness / medical condition</p> <p>11.1.2. Restricted with same injury / illness / medical condition for more than 3 months</p> <p>11.1.3. Has demonstrated an ability to achieve the EMQS in the 12 months prior to their illness / injury / medical condition.</p> <p>11.2. Although the above criteria is a minimum, before a Medical Wildcard is approved, additional consideration would be given as to the time of the season in which the injury / illness has taken place and whether or not the injury / illness / medical condition has led to the athlete not having had the same opportunity to compete as other athletes.</p> <p>11.3. An athlete who is awarded a Medical Wildcard has to have in place a performance readiness plan to demonstrate that they have returned to full fitness and are competitive in the respective category by an agreed date with the Olympic Performance Manager.</p> <p>11.4. To apply for a medical wildcard athletes must apply in writing to the Olympic Performance Manager, Rikki Bingham – Rikki.bingham@archerygb.org no later than 12:00 on 30/09/2023.</p> <p>11.5. Applications must state which of the criteria has been met. Athletes will also need to provide medical evidence to support their application for the AGB medical teams review, who may require further information or access to medical records.</p> <p>Selection Wildcard:</p> <p>11.6. Can be awarded where an athlete may have been unsuccessful in achieving the criteria to be invited to Selection Shoot stage 1 but is deemed to be at a highly competitive level. Examples of where a selection wildcard may be offered include, but are not limited to: (i) having less opportunity to achieve selection criteria due to attendance at international events within the selection window; (ii) having demonstrable medal winning potential based on previous medal winning pedigree withing the past 4 years.</p> <p>11.7. The Eligibility Score as set out in Section 5.5 must be achieved to be considered for a Selection Wildcard.</p> <p>11.8. The ultimate decision on a Selection Wildcard is made by the Performance Director in consultation with the Selection Panel.</p>
<p>12. Quota spot allocation</p>	<p>12.1. Due to changes to the qualification process for the Paris Olympic Games, there are a series of permutations regarding when spots are won, and then how selection against these spots will be made. It may be the case that the womens and mens spots are allocated differently, as described below, dependant on when team and individual quota spots are won.</p> <p>12.2. The selection panel (as described in section 13) will select as follows:</p>

Teams

12.3. Following the conclusion of selection shoot stage 3, a team of 3 athletes plus reserve will be selected for both Recurve Men and Recurve Women.

12.4. This will be the team that are nominated to the selection panel as the 'teams' for the 2024 season. This includes the Paris 2024 Olympic Games, providing a team quota spot is obtained in either 2023 or 2024 via any of the qualification routes including World Ranking.

Individual

Individual Spots won in 2023

12.5. If an individual quota spot has been won at the 2023 World Championships or European Games *and* a team spot is not won by the end of the qualification process then Archery GB would nominate to the selection panel the athlete who has the highest World Ranking points.

12.5.1. Due to World Rankings now including indoor and field events, selection will be based upon the cumulative total of the top 4 eligible outdoor world ranking scores as at 24/06/2024.

12.6. Only athletes who made the team of 3 selected individuals for the European Championships and Final Qualification Tournament in 2024 will be considered for this quota spot.

Individual Spots won in 2024

12.7. If an individual quota spot is won in 2024 at the Continental Qualification Tournament or Final Qualification Tournament *and* a team spot is not won, then the athlete who wins the quota spot will be nominated to the Selection Panel for selection.

12.8. If an individual quota spot is awarded after the Final Qualification Tournament as an unallocated quota spot, this will be awarded to the NOC and Archery GB would nominate to the selection panel the athlete who had the highest World Ranking points.

12.8.1. An unallocated quota spot will be notified to Archery GB by the 29th June 2024. Any spots offered after this date would be subject to Section 15 (Handback Places)

12.8.2. Due to World Rankings now including indoor and field events, selection will be based upon the cumulative total of the top 4 eligible outdoor world ranking scores as at 24/06/2024.

12.9. Only athletes who made the team of 3 selected individuals for the European Championships and Final Qualification Tournament in 2024 will be considered for this quota spot.

12.10. The selection panel reserve the right to make changes to the athletes / teams selected at selection meeting 2 or selection meeting 3 based upon maintaining performances at international events in 2024, behaviour, contribution and impact on team both at the event and within the day to day environment.

<p>13. Nomination and Selection Panel</p>	<p>13.1. The following selection meetings will take place as part of the selection process:</p> <p>13.1.1. Selection Meeting 1: Following the conclusion of Selection Shoot Stage 1 to confirm athletes progressing to Stage 2 and to confirm the athletes attending the Spring Arrows World Ranking Event</p> <p>13.1.2. Selection Meeting 2: Following the conclusion of Selection Shoot Stage 2 to confirm athletes progressing to Stage 3</p> <p>13.1.3. Selection Meeting 3: Following the conclusion of Selection Shoot Stage 3 to select the Team and Reserve(s) for the European Championships, Final Qualification Tournament and World Cups 2 and 3</p> <p>13.1.4. Selection Meeting 4: Following the final allocation of quota spots after the Final Qualification Tournament and updated World Ranking List for final nomination to BOA.</p> <p>13.2. Following the conclusion of the selection process, Archery GB will nominate the athletes to the BOA who will, through their own Qualification and Selection Panel endorse (or not) the nominations and then select these athletes to represent Team GB.</p> <p>13.3. The representatives at the selection meetings will be made up of the following;</p> <p>13.3.1. Performance Director (Chair) or other nominated member of Performance Management Team</p> <p>13.3.2. Olympic Performance Manager</p> <p>13.3.3. Performance coaches working within the Olympic Programme</p> <p>13.3.4. Independent performance expert(s)</p> <p>13.3.5. A member of the British Olympic Association (observing)</p> <p>13.4. In selecting a team that is in line with section 1, the panel will consider all available information, including, but not limited to the performances throughout the selection shoot process, attainment of the enhanced minimum qualification standard, medal target, recent performance pedigree (including international medals won), behaviour, contribution and impact on team both at the event and within the day to day environment.</p> <p>13.5. There is no obligation for the BOA to accept any hand back places that are not qualified through the standard qualification route.</p> <p>13.6. There is no obligation to send full categories if it is not deemed to be in the Programmes interest and the selection panel may elect to select fewer than the maximum permitted athletes.</p>
<p>14. Reserves</p>	<p>14.1. To ensure that we can field a team for the team event the selection panel may nominate up to 2 reserves per category. The first reserve will travel to the World Cup events in 2024 but will not take part in the team round competition unless one of the selected team is unable to compete.</p> <p>14.2. It would be a condition of acceptance that identified reserves take part in identified and agreed elements of the Paris Preparation Plan and a requirement to maintain an agreed training programme.</p> <p>14.3. Although a reserve may attend the Paris Preparation Camp, they would not be a part of the Games itself or in the village.</p>

<p>15. Handback Places</p>	<p>15.1. The BOA's general policy on reallocated quota places (handback places) for all events is that the places will not be accepted.</p> <p>15.2. Archery GB can make an application to the BOA OQS Panel to consider accepting the place(s) should there be an extenuating reason, eg. if by accepting a handback spot it opens up a mixed team medal opportunity</p> <p>15.3. Handback places are often awarded at late notice with decisions often made within 24 hours of notification. The BOA shall have absolute discretion as to whether to accept any handback places and any decision relating to handback places is not subject to appeal.</p> <p>15.4. If Archery GB were to make an application to the BOA to accept a handback spot, it would be on behalf of the athlete whose result or world ranking that handback spot had been awarded on.</p>
<p>16. Team Announcement</p>	<p>16.1. Selected team members and any identified reserves must agree not to make any announcement to the media or public in any form (including on any social or other media) regarding their nomination until after Team GB have announced the selection.</p> <p>16.2. The Archery GB Olympic team will be announced once nominations have been ratified by the BOA.</p>
<p>17. The 'Team'</p>	<p>17.1. The 'Team' means the team which is nominated by Archery GB and then selected by the BOA which includes athletes, coaches, medical support personnel, team leaders and any associated members of the World Class Programme team.</p>
<p>18. Injury / Illness / Wellbeing</p>	<p>18.1. For any injury / illness / medical condition (physical or mental) that occurs during or in the lead up to the selection shoot and impacts an athletes ability to complete the selection shoot the following procedure will be followed:</p> <p>18.1.1. The injury / illness / medical condition would need to be reported immediately to the AGB approved medical personnel who may request an examination. Further medical clarification may need to be sought from the Chief Medical Officer or other nominated medical personnel.</p> <p>18.1.2. A decision will then be made as to whether an athlete is medically withdrawn from the selection shoot.</p> <p>18.2. If an athlete is medically withdrawn from the first or second selection shoot, the selection panel will consider all available information to determine whether the athlete will be awarded a space at the second or third selection shoot. This may include, but not limited to, performance within the selection process up to the point of withdrawal, previous performance pedigree, international competitiveness and future potential.</p> <p>18.3. If an athlete is medically withdrawn from the third selection shoot, the selection panel will consider all available information when selecting a team. This may include, but not limited to, performance within the selection process up to the point of withdrawal, previous performance pedigree, international competitiveness and future potential.</p> <p>18.4. At any stage following the selection announcement, should there be a doubt over the ability of an Athlete to compete to the best of his / her ability due to an injury or physical / mental health,</p>

	<p>the following procedure will be followed:</p> <p>18.4.1. In the case of physical injury / health, the athlete will be referred to the Archery GB approved medical personnel to undergo a medical examination to determine his / her fitness to participate, which at this stage will be determined based on an assessment of whether or not the injury and/or illness is such that the athlete is physically unable to compete or is at risk of causing medical harm to her / himself, or endangering other competitors, officials or spectators.</p> <p>18.4.2. If the athlete passes the medical examination but the Medical Personnel and/or Archery GB have concerns over whether the athlete is able to compete to the best of his / her ability due to the underlying injury or illness, the athlete will be required to undertake an Archery GB agreed Performance Readiness plan, which would include “Fitness Test(s)”.</p> <p>18.4.3. The Fitness Test(s) will require the athlete to compete under ‘controlled competition conditions’, as a minimum, in the distance and format which replicates the required competition demands and demonstrate a return to competitiveness. The athlete will be allowed two attempts to satisfy these requirements.</p> <p>18.5. In the case of any concerns around an athlete’s mental health, Archery GB may be required to seek expert advice and input from the EIS Mental Health Expert Panel. In certain situations this may require the athlete to undergo a mental health assessment either with the CMO, through the Mental Health Expert panel or identified external specialist which may include the development of an agreed plan to manage any identified risks and maximise positive mental health until the conclusion of the event.</p> <p>18.6. In the event that an athlete fails to complete the Fitness Test(s) to the required standard or it is deemed they are not fit to compete from a mental health perspective, the Performance Director/CMO may recommend that the selected athlete be de-selected and replaced with a reserve, such reserve to be selected at Archery GB’s sole discretion.</p>
<p>19. During and on the conclusion of the selection process.</p>	<p>19.1. Throughout the selection process and once selections have been confirmed by the Performance Director / Olympic Performance Manager, all selected athletes (including any identified reserve(s)) must agree not to withhold any information on training fitness, injury status or physical / mental health that could affect training or competition at any time until the conclusion of the event.</p> <p>19.2. All selected athletes must declare any medications they are taking, in particular the use of any restricted medications and that they hold a valid Therapeutic Use Exemption (TUE) which can be produced when required by the relevant authority;</p> <p>19.3. An athlete and other Team members will be required to sign up to the relevant Code of Conduct or Athlete Agreement and any breach of this may result in disciplinary action including removal from the team and possible early return home from an event. In this case any member sent home will be invoiced for the full cost of their entry into the event and any additional cost incurred in sending them home.</p>

	<p>19.4. Decisions on these matters are open to appeal as allowed by the relevant Archery GB Disciplinary process effective at the time of the incident.</p> <p>19.5. All athletes/team members are required to complete / attend all necessary pre-games education and administration, including, but not limited to Anti-doping education, accreditation portal, kitting out.</p> <p>19.6. To be eligible to participate in the Olympic Games all athletes, including those receiving Tripartite Commission Invitation Places, must have achieved the following Minimum Qualification Score (MQS) between 1st day of the World Archery Championships 2023 and 28 June 2024 by name at a WA registered event.

Men	640	70m round
Women	610	70m round

World Archery (“WA”) will review the scores of all entered athletes to verify that they have achieved the above mentioned requirement. The WA executive committee will make the final determination on the eligibility to participate in the Olympic Games of any athlete who has not met the MQS at a WA registered event but can demonstrate adequate proof of reaching the MQS. This process will be completed by 30 June 2024.
